

Colleges and Courses

The Government has delegated the powers to grant permission for starting of New Private Unaided Degree Colleges / Courses and Post Graduate Courses to A.P. State Council of Higher Education through G.O.Ms.No.278 Edn., Dt:24.07.1995. Government also delegated the powers for according administrative sanction for the establishment of Law Colleges in the state of Andhra Pradesh through G.O.Ms.No.224 Edn. Dept., Dt:16.7.1999 and the power for according sanction of New Private Un-aided Oriental Colleges in the state of Andhra Pradesh through G.O.Ms.No.6 Higher Education (CE.II) Dept., Dt: 3.2.2004.

(a) The basic requirement to start New Private Un-aided Degree colleges are :

3.	<i>Building Accommodation</i>	<p><u>URBAN AREAS</u></p> <p><i>Minimum 8000 sq.ft. Own/leased building registered in the name of the Society.</i></p> <p><u>RURAL AREAS</u></p> <p><i>Minimum 6000 sq.ft. Own/leased building registered in the name of the Society.</i></p>
4.	<i>Land</i>	<p><i>One acre</i> own land registered in the name of the Society in 5 places i.e. Hyderabad, Warangal, Visakhapatnam, Vijayawada & Guntur.</p> <p><i>Two (2) acres</i> of own land registered in the name of the Society in other places.</p>
5.	<i>Other Requirements</i>	<p><i>Play ground, parking area, fire safety certificate, details of staff, registration of the Society.</i></p>

(b) The basic requirements to start additional UG Courses / Combinations / Sections in the existing Private Degree Colleges

Sl. No.	Requirement	Description
<i>In addition to the requirements mentioned for starting of New Degree Colleges, the following requirements shall be fulfilled.</i>		
1.	Permissible Courses	Only three UG Courses / Combinations / Additional Sections are permitted per year.
2.	Financial Resources	For One Courses : Rs.2.00 lakhs For Two Courses : Rs.3.50 lakhs For Three Courses : Rs.5.00 lakhs FDR for the amount mentioned above shall be taken for a period of 6 months in the name of Secretary / Correspondent of the Society.
3.	Building Accommodation	As per the requirements of the existing and proposed Courses / Combinations

(c) Basic requirements to start New PG Courses in the existing Private Degree Colleges

Sl. No.	Requirement	Description
<i>In addition to fulfilling the requirements mentioned ABOVE i.e. for starting of New Degree Colleges, the following conditions shall be fulfilled.</i>		
1.	Eligibility	5 years of existence of Degree College The subject proposed for P.G program shall be taught at Degree College for three years. Own building in the name of the Registered Educational Society.
2.	Permissible Courses	Only two PG Courses are permitted per year.
3.	Financial Resources	FDR for Rs.35.00 lakhs should be taken in favour of Secretary of Society for a period of 6 months for BIOTECHNOLOGY Course. No financial resources required for other PG Courses.
4.	Building Accommodation	M.Sc. (Chemistry combinations / Microbiology) – 7100 sq.ft. (2 classrooms, 3 labs, seminar hall and library) are required. M.Sc. (Computer Science / Botany / zoology / Physics) – 3600 sq.ft. (2 classrooms, 2 labs) are required. M.Sc. (Biotechnology) – 10,100 sq.ft. is required. M.A. / M.Com. / M.Sc. (Mathematics) – 2400 sq.ft. is required.
5.	Corpus Fund	FDR for Rs.5.00 lakhs taken in Joint Account of Secretary of the Society and RJDCE concerned for a period of 10 years per Course.
