Further it is also to inform you that extension of affiliation be considered only to those Engineering, Pharmacy and other professional colleges (MBA,MCA,B.Ed,Law etc.) under the jurisdiction of University, which fulfill the norms of the AICTE, University Government and other statutory bodies strictly. The following norms are subject to be followed.

1. Student-Teacher ratio as per AICTE norms.
2. Faculty cadre ratio as per AICTE norms
3. Lab facilities as per AICTE norms
4. Registration of the faculty on the VIDYAWAN Website
5. Compliance of AADHAR based bio-metric attendance.

It is therefore, requested to maintain websites in all Engineering, Pharmacy and other professional colleges(MBA,MCA,B.Ed,Law etc.) and is mandatory.

If the college fail to follow norms prescribed above and the deficiencies are not fulfilled the University will not accord the extension of affiliation in future.
