PROCEEDINGS OF THE VICE-CHANCELOOR

Sub: Meeting of the Education Colleges-Review on problems -Resolutions taken and approved -Reg.

- Ref: 1) Minutes of the meeting held on 07.03.2017 at Seminar Hall.
2) Resolutions finalised by the committee members, dt. 09.03.2017.
3) The same resolutions approved by the Vice-Chancellor on dt. 17.03.2017.

ORDERS:

As per the discussions had in the above meeting, Vice-Chancellor is pleased to approve the following resolutions as detailed below:

1. **Regarding Deficiency of Fire Safety Certificate submission by the Education Colleges:**
Resolved to give permission for 4 months for submission of fire safety certificate from the date of issuing this orders subject to the condition of submission of chalan/ receipt of paid to the authority of fire office as a proof immediately.
2. **Regarding Intake Strength reduction :**
Resolved to approve the following procedure for reduction of intake strength by the colleges who has applied for decrease of intake strength from 100 (2 units) to 50 (one unit) i.e., college management have to submit the copy of the resolutions taken by the Governing Body of the society along with Rs. 100/- notarised affidavit. However, as and when the college desires to increase the intake. In such cases, they have to approach the university, which would constitute a committee to examine the viability of infrastructure and instructional facilities available in the college. Based on the nature of the recommendation of the committee, University may increase the intake strength of the college. Accordingly intake strength permitted, staff should be appointed and get ratified by the University in this regard.
3. **Regarding faculty appointments in Women Education Colleges:**
Resolved to ratify women faculty only in women's colleges. But if there is non-availability of women faculty in spite of the consecutive 3 advertisements, then college has to bring the proof of non-availability of women faculty. In such situation, with the permission of the University, they may appoint a male faculty.
4. **Regarding Nil student's admitted colleges:**
Resolved that for the colleges which have no admissions of students in the entire course irrespective of this, Principal should be appointed and ratified for Correspondence between the University and College. The colleges have to pay all affiliation, inspection and renewal of staff fee to the university in order to continue the affiliation.

5. Regarding Moderation Board:

Resolved to have one/two senior faculty member of ratified staff of affiliated education colleges in addition to the existing faculty members in the moderation board.

6. Regarding Staff in not ratified colleges:


- i) Resolved to extend the date to appoint required number of faculty and get them ratified by the university within 20 days of issuing the circular.
- ii) Resolved to reduce fine from 1,50,000/- to 75,000/- (i.e., from 50,000/- to 25,000/- per semester) for the education colleges who did not appointed and ratified on or before 31.03.2017.
- iii) Resolved to constitute a moderation board as suggested above to evaluate the practical records of the student's for those colleges who have paid the fine/ penalty of 75,000/- in favour of the Registrar, ANUR, for not having the ratified Principal in the college.

7. Regarding fulfilment of deficiencies by the Education Colleges:

Resolved to extend the last date up to 10th April 2017 for fulfilment of deficiencies. The names of colleges which have fail to fulfil the deficiencies will not be recommended to Ed.CET 2017-18.

In accordance with above resolutions made regarding the concerned college managements those may be informed to act accordingly.
